- As we face warmer, drier years ahead, water managers, planners and decision makers need quick access to robust water data!

THE SOLUTION: THE WATER DATA ACT

Enacted by state of New Mexico in 2019 NMSA 1978, § 72-4B

Our Vision: New Mexicans will have accessible and useful data for water management and planning






EXAMPLE: GROUNDWATER DATA


- A water manager wants to understand how groundwater levels are changing in their region
- They have to track down water level data from many different agencies
 - USGS
 - NMBGMR
 - US Bureau of Reclamation
 - State Agencies
 - Municipalities
 - Conservation Districts



WEAVER: INTERWEAVING GROUNDWATER DATA SOURCES


- NMBGMR has developed a data sharing infrastructure that allows us to integrate multiple sources of groundwater data – We're weaving it together!
- Can turn on view federal, state, regional and local datasets
- Goal is to allow users to download in a unified format
- Will support aquifer characterization work ahead










Recurring State Funding Received and Still Needed for Each Water Data Act Directing Agency
